

Starting Your Patients on CIBINQO[®] or LITFULO[™]

Here are your prescription pathway choices:

Specialty Pharmacy Providers

SEND the prescription to one of the Pfizer-partnered Specialty Pharmacy Providers (SPPs).
View a complete list of SPPs on the next page.

- **CIBINQO is available in an open network**, in which you are able to send prescriptions to any specialty pharmacy. CIBINQO is broadly available via open distribution and prescriptions may be sent to any Specialty Pharmacy of the patient's choosing.
- **LITFULO is in a defined distribution network (DDN)**, and is **only** available through select specialty pharmacies.

Pfizer has contracted with 10 Specialty Pharmacies to provide product-specific support. The listed specialty pharmacies may be helpful to review. Pfizer does not endorse the use of any particular pharmacy.

PFIZER DERMATOLOGY patient access[™]
